<p>Reflection</p>	<p>The reflection should demonstrate your learning and professional growth through this semester. Your reflection should address the following criteria:</p> <ul style="list-style-type: none"> • Write ONE reflection • Describe your professional growth through this semester • Support your learning with links to relevant artifacts. • Detailed description of interactions/ collaboration with diverse students, to include the following categories of students: socio-economic, ethnic/racial, students with disabilities, and limited English proficiency. • Provide evidence of your impact on student learning. • Within the reflection, state which Kentucky Teacher Standard each artifact addresses. Keep in mind that an artifact may address more than one Standard. You are encouraged to use the wording of the Standard in your reflection. <p>Through your reflection, you want to demonstrate a clear connection between what you have learned, the artifacts you offer as support, and the Kentucky Teacher Standards you address.
