

Program Data Point 11. Student Clinical Site Evaluations

In Spring 2016, the faculty created and offered a survey in which students had the opportunity to evaluate their site experiences. Figures 1, 2, and 3 below show students' ratings of their site supervision, practice opportunities, and overall site experience from Spring 2016. Overall, students rated their site supervision experience as both adequate and effective. Students rated their practice opportunities and overall site experiences as moderately to very satisfactory.

Figure 1. Students' Overall Perception of Site Supervision

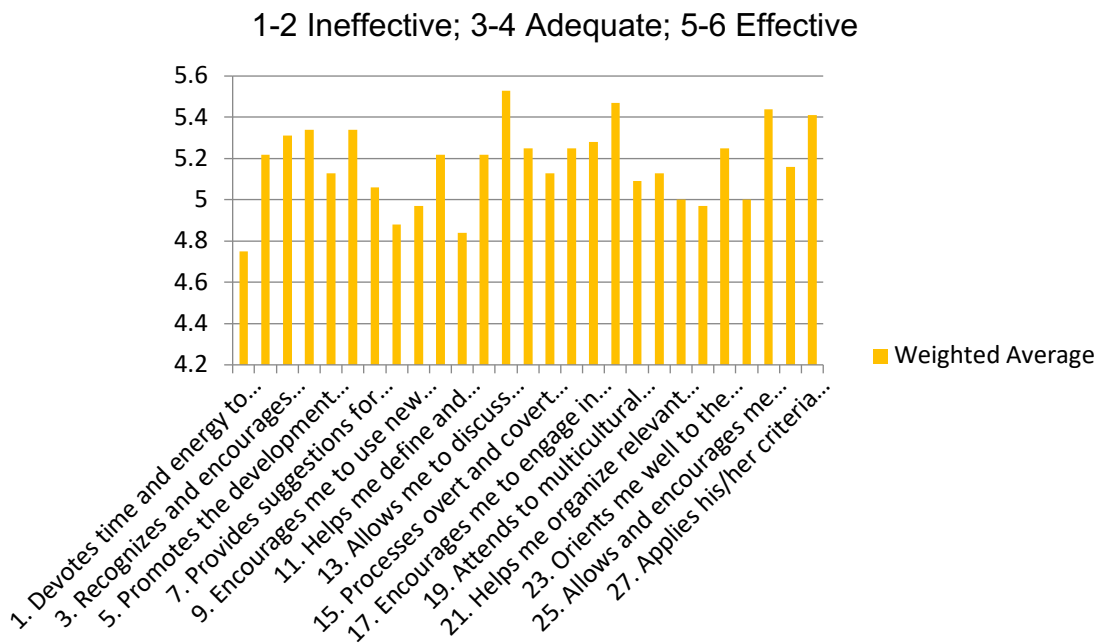


Figure 2. Students' Satisfaction with Site Practice Opportunities

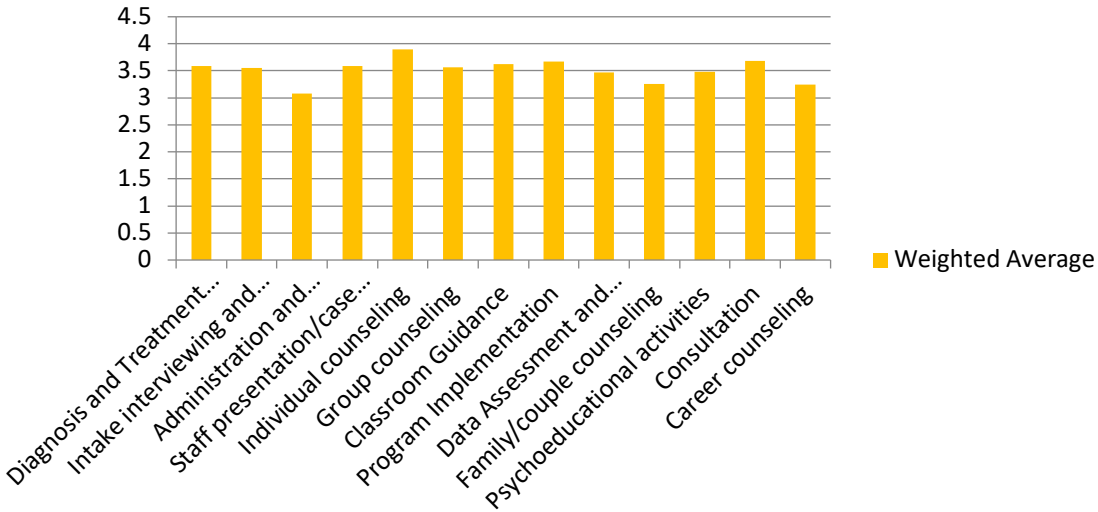
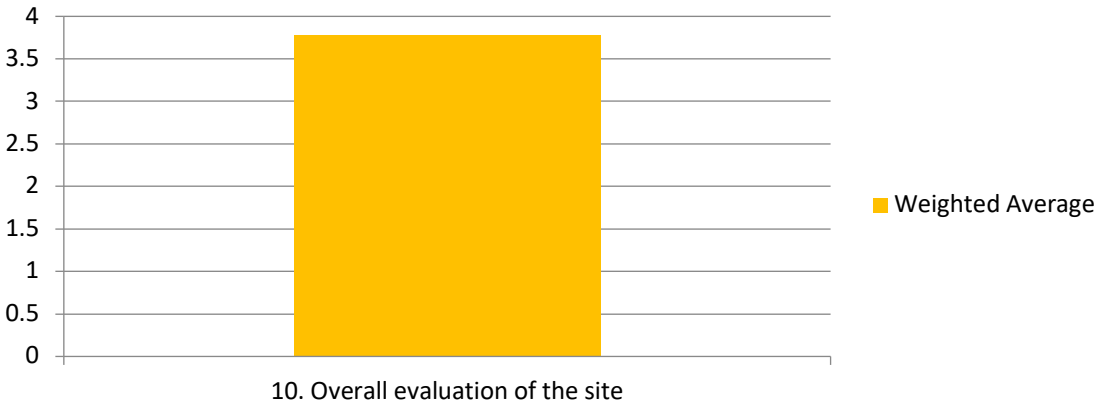


Figure 3. Students' Overall Satisfaction with the Site Experience

Based on feedback from students, the program developed a more-concise set of questions aimed at evaluating site supervision and students' overall site experiences. Faculty piloted the updated survey at the end of Fall 2017, and decided further revisions would prove beneficial. However, with the departure of the program chair at the end of Spring 2017 and the unexpected resignation of the clinical coordinator during the first week of the Fall 2018 semester, no progress was made on the aforementioned revisions, nor were any data collected relevant to this data point. The faculty resumed the supervisee evaluation of sites and site supervisors during the fall of 2019. The following table details the data collected.
