- The other members of the Alumni Association Board of Governors shall be elected by the members of the NKU Alumni Association for terms of three (3) years.

- The Alumni Association Board of Governors shall be elected by the members of the NKU Alumni Association for terms of three (3) years.
- No elected member of the Board of Governors shall serve more than two (2) consecutive terms for a total of six (6) years.

Operating Procedures:

- The President presides at all meetings of the NKU Alumni Association and performs all duties usually performed by such an officer.
- The President-Elect presides in the absence of the President and assumes the office of President for the expired term should the President no longer be able to discharge the duties. The President-Elect shall have such powers and perform duties from time to time be assigned by the President.
- The Secretary/Treasurer coordinates all activities of the NKU Alumni Association and performs
 all duties usually performed by such officer. The Secretary/Treasurer shall be directly
 responsible for carrying out the program of the Association as approved by the Board of
 Governors and shall be responsible for budget and fiscal policy recommendations.
- The Vice President shall be responsible for developing alumni support and participation regarding NKU Alumni Association activities and programs. The Vice President shall also perform duties as assigned by the President.
- The meetings follow Roberts Rules of Order.
