## **Membership Guidelines:**

All Board of Visitors members are appointed by the Dean of the Chase College of Law. Currently, the Board is comprised of 120 members. Of those members, 114 are Chase alumni and 6 are Chase friends.

**Membership Appointment:** Board members are appointed by the Dean.

**Membership Terms:** Board members serve 3-year terms; members may be reappointed without limitation.

## **Frequency of Meetings:**

Semi-annually. Many of the 120 board members live outside of this region. The average attendance at the board's semi-annual meetings has been approximately 35 members.

**Expected Lifespan:** Ongoing

# **Reporting Requirements:**

The Board reports to the Dean of the Chase College of Law.

**Operating Procedures:** The Board's Chair and Vice Chair are appointed by the Dean of the Chase College of Law. The Dean and the Board Chair appoint committees, on an ad hoc basis, for particular focus areas. The committees make recommendations to the Dean.
