INSTITUTIONAL REVIEW BOARD (IRB) FOR THE PROTECTION OF HUMAN SUBJECTS

Purpose:

Ensure compliance with Federal Wide Assurance provided by Northern Kentucky University to the Office of Human Research Protections, Department of Health and Human Services, Washington, DC

Charge:

 Review all undergraduate, graduate, staff, faculty and external research protocols that meet the federal definition of human subjects research for procedural adherence to Title 45 Code of Federal Regulations, Part 46, the Belmont Report, and subsequent federal regulatory interpretation

Membership:

The Institutional Review Board (IRB) is comprised of tenured faculty, tenure-track faculty, and research compliance professionals at Northern Kentucky University, particularly those who conduct human research, oversee undergraduate or graduate student human research, or teach human research methodology. The committee also includes non-NKU community members as required by federal guidelines.

Membership Appointment:

President with recommendation from IRB Chair and VP GERO

Membership Terms:

Three (3)-year terms by presidential appointment, with renewal at the recommendation of the IRB Chair, VP GERO and approval of the president.

Frequency of Meetings: Monthly, as needed

Expected Lifespan: Ongoing

Reporting Requirements:

The IRB operation is managed by the Office of Research, Grants, and Contracts, and ultimately is the responsibility of the Vice Provost for Graduate Education, Research, and Outreach. The IRB review process is intended to function independently by federal regulation.
