# **Other Policies**

1. Attendance: Students are allowed ONE unexcused absences without penalty. Upon the second unexcused absence, the student will incur a 5% reduction of the <u>total course grade</u>. On the third unexcused absence, and beyond the student will incur an additional 5% penalty for each absence. Absences are only excused if the student requests approval for the absence in writing one class period before the anticipated absence, or for illness/injury with a supporting note from a qualified medical professional (Nurse, PA, MD, or DO). The instructor will determine the validity of all absences. Any assignments/tests that are completed in class that is missed can only be made up if a valid written documentation explaining the absence is provided.

#### 2. Tardiness:

Arriving on time for class is an academic courtesy to fellow students and the professor. Students will be considered tardy when arriving 10 minutes after the stated class starting time. Students are allowed **two** tardiness without penalty. Upon the third tardiness, the student will incur a 3% reduction of the <u>total course</u> <u>grade</u>. On the fourth tardiness, and beyond the student will incur an additional 3% penalty for each tardiness. (ex: 300 pts, 3% = 9 pts/class).

#### 3. Late Assignments/Makeup Policy

All assignments must be turned in *prior to the beginning of class.* All assignments will be turned in on **Blackboard** – please do not email assignments. Assignments turned in after the beginning of class or will receive **10%** deduction in the grade. An additional 15% point deduction will be taken each day (starting at midnight) the assignment is late.

For example if your assignment was due Wednesday, January 28th at 8:00 am. (worth 20 points) and you submitted it Thursday, the 29th at 7:00 a.m. – you will lose 25% (5 points).

# 4. E-mail

I am responsive to e-mail questions (usually within 24 hours), but understand that I am less responsive and at times unresponsive on the weekends. Do not wait until the day / night before an assignment is due to ask an important question through e-mail.

A second note on e-mail – When writing an e-mail to me, write it in a manner that you would use to write to a principal or boss. It does not need to be overly formal, but it does need to be professional. Avoid shorthand (u for you, etc.), follow capitalization and grammar rules, and make sure to sign your name at the bottom.

Finally – please be as specific as possible in the email. The more information that you are able to tell me about the problem the more I may be able to piece together a solution. But remember there are multiple systems and errors that can occur... If that happens please call the help desk (on campus = 6911, off campus = 859.572.6911)

# 5. Grammar and Spelling

All assignments will be graded not only for content but also for spelling and grammar usage. Although not specifically stated in the rubric, it is expected that you will check all assignments sentence fragments, sentence structure and misspelled words.

In accordance with federal policy, NKU defines a credit hour as the amount of work represented in the achievement of student learning outcomes (verified by evidence of student achievement) that reasonably approximates one hour (50 minutes) of classroom instruction and a minimum of two hours of out-of-class student work. For every course credit hour, a typical student should expect to spend at least three hours per week of concentrated attention on course-related work including, but not limited to, class meeting time, reading, reviewing, organizing notes, studying and completing assignments. At least an equivalent amount of time is expected for other academic activities such as online courses, laboratory work, internships, practical, studio work and other academic work leading to the award of credit hours.

Estimates of the time required for a typical student to complete course expectations are as follows:
