Director's Corner

At the recent National Association for School of Public Affairs & Administration annual conference in Seattle, one of the keynote speakers emphasized the public service dimension of the PA community's identity and urged us to celebrate and take pride on that distinctiveness. As I am writing this piece, I ask myself this question: what do we do, as a group, to maintain our distinct identity? With pride and satisfaction, I say, "we are constantly engaged in public service." The MPA faculty are very engaged and dedicated in their public service mission as you will find under "Faculty Updates" in this edition. Students in several MPA classes have made valuable contributions to different organizations

and the community. Our alums are now everywhere in all different governmental and nonprofit organizations. Last semester, in my capstone class, I invited three speakers – all three highly accomplished in their career. Later on, I realized that they all graduated from our MPA program. It is getting difficult ... to find highly accomplished practitioners in this metropolitan region who are not our alums!

I want to report some of the major developments in our program. We now have a separate **MPA Foundation Account.** The account started with a recent policy that the MPA faculty adopted to request donations from agencies for services that we provide them through faculty and student pro-

jects. Our plan is to use this account to provide support to different student activities (i.e. attending conferences, club activities, etc). This semester, the faculty have worked together to propose some major curriculum revisions to our MPA program. Some of the key changes include: (1) adding a foundation course to our core curriculum; (2) developing two courses from our existing Research Methods (PAD 615) course: Research Methods will cover both quantitative and qualitative research methodologies,

Faculty Updates

Dr. Julie Olberding

Dr. Olberding presented a paper that she co-authored with Dr. Ahmed at the 2007 Annual Conference of the American Society for Public Administration (ASPA) in Washington, D.C. A version of this paper - entitled "Can Student Philanthropy Help to Address the Current Nonprofit 'Identity Crisis'? A Case Study of a Multiyear, Multidisciplinary Project at Northern Kentucky University" - was accepted by the *Journal of Public Affairs Education* for publication. Dr. Olberding continues to engage her classes in student philanthropy and service learning. Her Resource Acquisition class in Spring 2007 was part of a pilot project for a new approach to student philanthropy in which students work with Citigroup to review real grant proposals and make funding recommendations to its board. Dr. Olberding was awarded a Summer Fellowship to support her research.



Dr. Julie B. Raines

Dr. Raines' dissertation has been accepted for publication as a book with Jones and Bartlett Publishers –Titled, <u>Fostering Integrity in Police Agencies: Transforming Police Attitudes Towards Peer Misconduct</u>. Dr. Raines presented an article, "EI Al Passenger Profiling Revealed", at the Midwest Political Science Conference in Chicago this past April during a session entitled "International Security and Human Rights." In addition, Dr. Raines has written several grant proposals and two grant pre-proposals this year, and some of these were awarded funding.

Dr. Hongmei Wang

Hongmei Wang, an assistant professor in the Department of Computer Science, started with NKU in 2007. Her teaching focuses on Geographical Information Systems (GIS); She is developing several new GIS courses, which includes Spatial Database and GIS Programming Basics. Dr. Wang brings 10 years of research experience related to GIS development and applications to the program. Her research focuses mainly on GIS, including GIS interface development, context-modeling and uncertainties handling inhuman-GIS communication, spatial analysis using GIS, system evaluation, and applications of GIS and Remote Sensing techniques in various domains. Dr. Wang teaches the MPA GIS courses.

Dr. Ahmed presented a paper titled, *Merit Pay in an Unionized Setting: Lessons Learned*, at the SouthEastern Conference for Public Administration. Her co-author is John Downs. John graduated from the MPA program in Spring 07. Dr. Ahmed participated as a moderator at NKU's Asian Summit held this past summer. She is the current faculty advisor for the MPA Student Club.



and Data Analysis will cover both quantitative and qualitative data; (3) developing four concentrations on: nonprofit management, homeland security, metropolitan governance, and general public management. Students will choose one of the concentrations. We are confident that these curriculum revisions will make our program stronger and will prepare our students better to serve the changing needs of public service.

Life After the MPA Program

Ms. Cumbee has had the unique opportunity to assist in the establishment of Kids Count Inc. as a non profit, including applying for 501c(3) status for the organization. Kids Count Inc. contracts therapists trained in Developmental Intervention, Speech, Physical, and Occupational Therapy and Primary Service Coordination to perform Early Intervention Services with the 0-3 year population in Boone, Campbell, Kenton, Grant and Pendleton counties; through Kentucky's First Steps Program. Kids Count Inc. is recognized by the State of Kentucky as an Accredited Training Organization that serves preschool, daycare and Montessori school teachers throughout Northern Kentucky through monthly training seminars and conferences. The goal of Kids Count is to tailor training to the various learning styles and levels of experience of the participants. "We offer a variety of information on multiple levels, using various learning techniques, so every participant gains valuable information to take back to their centers".

Kids Count Inc. is growing. The Early Intervention Therapy Program is currently training and certifying new therapists to make it possible to serve more children and families in Northern Kentucky. The Daycare/Preschool Training Program is expanding into Southern Ohio/Cincinnati by of the end of 2007. In mid 2008 the organization plans to launch Consultative Daycare/Preschool Training Program. This new program is a holistic approach to training. The program is focused on individual preschools, daycare centers and Montessori schools. The purpose is to evaluate issues unique to each individual setting; to develop effective plans that address the identified concerns and to train the centers to incorporate more effective approaches into their preschool/ daycare/Montessori settings.

Ginger Cumbee now works as the Development Director for Kids Count Inc.

Broadening the Learning Environment: Student Experiences

Elishia Chamberlain: Ethics and Leadership Conference

On April 24, 2007 Elishia Chamberlain and Travis Crawford (MPA alum, 2007) attended the Third Ethical Leadership Institute Conference held at the Lexington Center in Lexington, KY.

The purpose of this conference was to understand the impact of ethics and values on an organization. The conference was designed to not only educate, but generate ideas on ethical best-practices. Some of the nation's top businesses were represented at the conference with speakers from such companies as Toyota, Starbucks, Lexmark, and UPS.

Attendees were invited to hear a variety of

speakers who shared in their company's experiences and methodologies with business ethics. Several workshops and forums provided for an atmosphere of openness and discussion. Roundtable discussions occurred at intervals throughout the day where graduate students, field experts, educators, and business leaders generated solutions to ethical questions and scenarios.

whether it is for profit, non profit, and/or government. I also feel that NKU was wise in choosing two MPA students to represent the university as well as MBA students. Attending the ASPA convention became attractive to Justin because of the 2007 theme: *Capitalizing on Collaboration*. Justin has always held an interest in homeland security and disaster management and this past year ASPA was particularly concerned with the natural disaster of Hurricane Katrina. Large portions of the sessions were devoted to the collaboration of services: public, private, and non-profit in the event of a natural disaster. A highlight of the conference was a speaker discussing a journal article he had written, which Justin had

After 4:30 p.m. each night there were events held for the attendees specifically geared toward networking.

Bridging Theory and Practice

Mentoring Project in Local Government Management

Last spring, Dr. Fred Rhynhart's Local Government Management course (PAD 675) included an experiential component using area local government managers. Each student in the class was assigned a local government manager as a mentor. Students were required to: (1) shadow his or her mentor through a day, (2) attend a local council meeting, and (3) interview the mentor. Melissa Williams (Director of Administration, Campbell County Fiscal Court, and a member of the MPA External Advisory Board) assisted Dr. Rhynhart with this project. At the end of the semester, Dr. Rhynhart sent a survey to all the mentors asking for their feedback on this course component. The majority reported great success and all mentors agreed that they would participate again. Due to the great success, this project will be incorporated in future offerings of this course.

Student Philanthropy Drives the Lessons Home - Sonya Turner Thielmann

Those who write grants and fundraise dream of one day being on the other side. Imagine having thousands of dollars to give away and the chance to choose the best causes to support! Students in Resource Acquisition and Management got to do just that last spring, with support from the Mayerson Student Philanthropy Project. The assignment? To read through a stack of grant applications that had been sent to the Citigroup Foundation and find one or two to recommend for funding.

As the students stared at the thick proposals, suddenly the reason for all those grant writing tips imparted in class became crystal clear. Tip No. 1 – Be concise. Tip No. 2 – Be clear. Most importantly, do not put the grant reader to sleep. The class learned that it is hard to evaluate grants without clear guidelines. Every cause was worthy – the only way to choose was to evaluate which aligned most closely with Citigroup's priorities.

After some debate, the class chose two proposals. Students Barry Thiel and Sonya Turner Thielmann presented the choices to the Citigroup committee. Although Citigroup chose to fund neither of the class' choices, students still learned the most important lesson of all: You can have a worthy cause, write a great proposal and be aligned with a foundation's priorities and *still* not get funded. There is only so much money to go around. Students also developed more understanding for those foundation officers who wade through stacks of proposals and have to make difficult, sometimes agonizing, decisions about which to fund.

Selective Capstone Projects: Class of 2007 fall

Students in Dr. Ahmed's capstone class are required to complete a major project. The project could be a major research or policy paper, action research, program evaluation, review of best practices, etc. Snapshots of some of these projects are:

Deborah Kittner conducted a survey to assess NKU faculty's background, skills, experience, activities, linkages, and interest in internationalizing the campus. She is also a member of the Campus Internationalization Task Force. Under Dr. Ahmed's guidance, she used *survey monkey* to distribute the survey to all full time faculty at NKU. The final report was submitted to the Task Force.

Travis Crawford & Bradley Sayles conducted a citizen satisfaction survey for Boone County residents. The Boone County Fiscal Court had contacted Dr. Ahmed for this project. Travis and Brad decided to complete that project as part of their capstone class requirements. Under the guidance of Jeffrey Earlywine (Boone County Administrator) and Dr. Ahmed, they designed the survey instrument and used random sampling to distribute the survey. At the end of the semester, they presented their findings to the Fiscal Court officials.
